Taan makuri aika a aekaki n te tai ae e onoti (ae to 9 te namakaina a aki kabaeaki ba a na karina aia booma.

## Tera te beebe ni bubuti ibukin te angabwai?

**Te Angabwai:** Ana karekemwane te Tautaeka. ## Ko na karina ia am bubuti ibukin te angabwai


