Ambina amin magur ian Aotereria ian bita Pacific Australia Labour Mobility (PALM) scheme e nan requireiy bwe ar nim lodgeiy wara **tax return form** tjinia ar eo maguren inimagen 1 oa 4 eoboni

Ambina magur ian mana seasonal edaei (eae 9 mwaramwin) eab requireiy ura nim lodgeiy wara tax return form.

## Iken kor tax return

**Tax:** Maketoatsinmwaramum pumweEdogurdugunbwein an amamo erut magur dugut engame Nim gona ranga ura me oiya ura mana services ekae dugun earak, kereri, railways, medena Ngane mane e magur Edogur riring tsmorun mag engame bina meg ian Aotereria.

**Tax return:** Tjinia timine wam mak awe gona ian bita eoboni (tekeiy jiaw magur inimagen July 2021 ea Jun 2022) nan wu needeiy wonum lodgeiy wam tax return.

## Itemwan an magur?

Jiaw magur nan awe kodogi pumwe wam income tax ian bita eoboni wu magur ian.

Amea wu magur tango nan teidan to mwaramum me nan sendeiy ea Aotereria Tax Office dugum. Ngea bita ouga nan Pay as You Go (PAYG) bwabujiyen. Ouga riringen bwe nim eo

ouwak wam tax i Jtinia magen eoboni. Nan awe gona aea ngaben wam tax e to atsin turun amea wu magur tangon ian wam pay slip.

Tjinia goron bita eoboni wu magur ean, ngea ATO nan ogen calculateiy wam mak amea wu magur tangon teidan ani ian mwaramum ian bita eoboni. Nan garo jiaw ura nan pumweu wam tax refund ao wunom puwme agoroan wam tax bill.

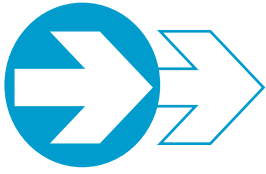
### Lodgeiy tangon accountant ao tax agent – nan timine pumwan.

## Nan egen rekoun daeiyeen processeiyen wanga tax return?

Ko daeiyeen awe gona tid rekoun processeiyen wam tax return atsin turun ATO. Nan gona mwaramin tjinia ATO processeiy wam tax return. Ko engame gona awipio amamoen; nan awe obereiy.

## Ik et timin nim nga needeiy dugun amatuen waga ta return?

**Online income statements:** Nan awe gona aea ngaben wam mak me wam mak awe pumwe dugun wam tax bwein bita eoboni. A mea wu magur tangon gona oiya uw ao nan wugona aea ian wam MyGov account.

**Wam receipts dugun pumwen wam beit magur:** This includes items such as work clothes, travel receipts and personal protective equipment. Work related expenses can be claimed to reduce your taxable income.

## STEP 1

Accesseiy wam income statement. Nan wugona adji ian MyGov inimagen 14 eibumun ian 1 July

## STEP 2

Tjinia tawe lodgeiyu online, nanga ko MyGov website degeri dogorin

**Jiaw lodgeiy turun engame ion** (accountant ao tax agent).

- A accountant ao tax agent no wumeg ian – nan mo kor jiaw kudo i tangom magur ao mea wu magur tangon dugun mon nuwauwan.
- Nan awe bookeiy wam appointment ao naga e aobit. Nan wu needeiy wunom oiya ura angun pumwum ao/ me receipts.
- Nim garoau ngana nan gona timine pumwan. G Nan gona bet jia gona mea tax agent uda pumwen atjin ian wam tax refund.

## STEP 3

ATO ao mea wam tax agent nan panauw jiaw oweiy ura ao nan timine wam tax refund. Noteiy: Jiaw oweiy ura nan wu needeiy contacteiyen ATO dugun pumweiyen am dura.
