### Wanem ia superannuation?

Superannuation, o 'super', hemi wan sistem blong savings blong ritaemen long Ostrelia. Hemi olsem ol Nasional Providen Fand we oli operet long fulap Pasifik aelan kantri.

Taem yu kasem wok long Ostrelia, emploia blong yu i pem super long reit blong 10.5% long salari blong yu i ademap antap long nomol pei blong yu (infomesen ia i stret wan long 1 Julae 2022). Oli pem super blong yu i go long wan super fand we yu jusum mo bae i stap kasem taem yu klemem afta yu gobak long hom blong yu.

Bifo yu submitim klem blong super blong yu, jekem wetem emploia blong yu se oli bin pemaot ol benefit i go long fand we yu bin jusum. Emploia blong yu i mas pem super blong yu evri kwota (be sam emploia bae oli jus blong pem super moa eli).

*Notem se 10.5% Super Garanti hemi stap inkris long 0.5% evri yia long namba 1 Julae kasem taem i go long 12%.*

### Weanao mi save klemem super blong mi?

Apply for departing Australia superannuation payment and/or payment of unclaimed superannuation money: how to apply

This system will analyse your application for the departing Australia superannuation payment (DASP) from both super funds and the ATO. Please take some time to read through this section so you know what information you will need to provide to apply for your superannuation benefits using this system.

What you will be asked to provide

To help confirm your identity and security and process your application, you will need to provide the following information:

- Your name and other personal details
- Your e-mail address
- Your passport number
- Your Australian Business Number (optional)
- Your superannuation account details - including your super fund's Australian Business Number (ABN). You may use the system to conduct a search for the ABN based on the fund's name.

The application process

It will take approximately 30 minutes to complete the application online.

Confirm identity and eligibility

To protect your information, when you log onto the system you will be asked to create a 'shared secret' by selecting a question and supplying your answer. This system will encrypt and securely store this information. If you are applying for a DASP, you may only submit your application if you have departed Australia and your visa has ceased to be in effect (for example, it has expired or been cancelled). If you are still in Australia, or your visa is still active, you may save an application, but it cannot be submitted to your super fund(s).

Note: You must enter exactly the same personal details each time you access this system.

Secret password

To protect your information, when you log onto the system you will be asked to create a 'shared secret' by selecting a question and supplying your answer. This system will encrypt and securely store this information. If you are applying for a DASP, you may only submit your application if you have departed Australia and your visa has ceased to be in effect (for example, it has expired or been cancelled). If you are still in Australia, or your visa is still active, you may save an application, but it cannot be submitted to your super fund(s).

System searches for your superannuation

If you are leaving Australia, you are eligible to apply for a DASP. If you provide your TPI, the system will search the ATO's records to identify the super fund(s) where your previous visa has been held. Even if you may have transferred income to the ATO, we recommend you contact your super fund(s) directly. This will help them to update their records.

Add your contact and other personal details

You will need to provide your current contact details including your email and postal address. Your super fund and/or the ATO may need to contact you regarding your DASP application.

Your visa information

You will see the following: If you ever held a working holiday maker visa.

The Department of Home Affairs has advised that you may have held a working holiday maker (WHM) visa.

Yu save setemap wan DASP akaon blong yu bifo yu aot long Ostrelia.

## Olsem wanem sipos mi stap long moli-yia visa?

Si pos yu wan sisonel woka long wan moli-yia visa yu no save klemem super blong yu kasem las taem yu gobak long hom ples mo visa hemi ekspaea. NO kanselem wan moli-yia visa kasem taem yu finisim ol wok long Ostrelia. Si pos yu kanselem, bae yu mas pem wan niufala visa blong yu save kambak, mo maet oli no givim long yu.

## Haonao bae oli pem DASP?

Nomoli oli stap pem DASP insaed long 28 dei we yu submitim aplikesen blong yu si pos aplikesen hemi komplit. Si pos aplikesen blong askem peimen i no komplit o i nogat sam long ol sapoting dokumen we oli nidim bae i save dilei. Mekem sua se yu komplitim gud aplikesen.

Maet oli pem super blong yu i go long wan **bank akaon long Ostrelia**, o oli postem long yu olsem wan **jek long mane blong Ostrelia**, o oli pem tru long intenasonal mane transfea (blong ol super fand aplikesen nomo). Plante long ol bank we oli stap ovasis oli no akseptem jek blong Ostrelia mo i no evri super fand we oli provaedem trifala peimen opsen. Jekem wetem super fand blong yu long bes wei blong pem mo si pos i gat eni fi blong hem. Si pos

yu jusum blong oli pem super i go long bank akaon blong yu long Ostrelia, yu **MAS** lego bank akaon blong yu long Ostrelia i open.

Si pos yu no klemem DASP bifo long en blong 6 manis afta long ekspaea deit blong visa, maet oli muvum super blong yu i go long ATO mo holemaetae kasem taem yu klemem. Super we ATO i holem bae oli pem i go long wan bank akaon long Ostrelia nomo.
