Apply for departing Australia superannuation payment and/or payment of unclaimed superannuation money: how to apply

This system will analyse your to apply online for the departing Australia superannuation payment (DASP) from both super funds and the ATO. Please take some time to read through this section so you know what information you will need to provide to apply for your superannuation benefits using this system.

What you will be asked to provide

To help us confirm your identity and process your application, you will need to provide the following information:

- Your name and other personal details
- Your e-mail address
- Your telephone number
- Your passport number
- Your Australian Business Number (optional)
- Your superannuation account details - including your super fund's Australian Business Number (ABN). You may use the system to conduct a search for the ABN based on the fund's name.

The application process

It will take approximately 30 minutes to complete the application online.

Confirm identity and eligibility

To protect your information, when you first enter the system you will be asked to create a 'shared secret' by selecting a question and supplying your answer. This system will encrypt and securely store this information. If you are applying for a DASP, you may only submit your application if you have departed Australia and your visa has ceased to be in effect (for example, it has expired or been cancelled). If you are still in Australia, or your visa is still active, you may save an application, but it cannot be submitted to your super fund(s).

Note: You must enter exactly the same personal details each time you access this system.

Secret password

To protect your information, when you first enter the system you will be asked to create a 'shared secret' by selecting a question and supplying your answer. This system will encrypt and securely store this information. If you are applying for a DASP, you may only submit your application if you have departed Australia and your visa has ceased to be in effect (for example, it has expired or been cancelled). If you are still in Australia, or your visa is still active, you may save an application, but it cannot be submitted to your super fund(s).

System searches for your superannuation

If you are applying for a DASP, you are eligible to apply for a DASP if you provide your TFR, the system will search the ATO's records to identify the super funds where your permanent residence, may have been held. Even if you may have transferred income to the ATO, we recommend you contact your super fund(s) directly. This will help them to update your ATO record.

Add your contact and other personal details

You will need to provide your current contact details including your email and postal address. Your super fund and/or the ATO may need to contact you regarding your DASP application.

Your visa information

You will see the following: If you ever held a working holiday maker visa.

The Department of Home Affairs has advised that you have held a working holiday maker (WHM) visa.

Kudoiy amin rangae wam super dugun pumwan

sendeiyen wam mak. Tjinia wu tengeiy nim pumweau wam super ian wam Australian bank account, **WUNIM** ta bwaida wam Australian bank account.
