Wat nao superannuation?

Superannuation, o 'super', hem Australia's retirement savings sistem. Hem olsem nao Nasinol Provident Funds wea opereit lo Pasifik aelan kaontris.

Taem iu waka lo Australia, waka ples blong iu peim super lo 10.5% blo salari blong iu ontop nomol pei blong iu (stat lo 1 July 2022). Super blong iu hem pei go insaet nominated super fund, wea hem bae stap antil iu klaimim afta iu go bak lo hom.


Befo iu sabmitim super klaim, chek wetem waka ples blong iu dat olketa peim evri entaetolments lo nominated fund blong iu. Waka ples blong iu hemmas peim super quatali (samfala laek fo pei super staka taem).

NB. Disfala 10.5% Super Guarantee hem bae incris lo 0.5% increments lo evri ia lo 1 July antil hem kasem 12%.

Wat taem nao fo klaim super blong mi?

Iu save mekm superannuation pei go lo iu sapos iu:

- go finis from Australia
- lu no Australian o New Zealand citizen, o permanent resident blo Australia
- no holem Australian visa, diswan hem includim eni visa (includim tourist visas).

Iu save setemap DASP account blong iu bifo iu livim Australia. Statim DASP klaim blong iu taem iu stil stap insaet lo Australia taem iu go lo DASP Online en wakem wanfala 'shared secret'. Shared secret blong iu bae alaom iu fo kam bak lo DASP Online fo komplitim klaim blong iu taem iu go bak lo hom, en taem visa blong iu hem expae o kancel finis.

Iu bae nid fo garem akses lo komputa en intanet lo hom fo submitim DASP klaim blong iu onlaen. DASP blong iu bae save peim stret lo Australian bank account blong iu.

Hao na mi bae save sapos visa blong mi hem expae?

Bifo iu livim Australia, chekem visa expae deit. Waka ples blong iu save givim iu diswan. O iu save go in lo Visa Entitlement Verification Online (VEVO) system fo checkem nao aboutem visa blong iu.

Wat sapos mi lo multi-year visa?

Sapos iu wanfala seasonal waka man en mere lo multi-year visa iu bae no save klaimim super antil iu go bak lo hom fo last taem en visa blong iu hem expae. NO kanselem multi-year visa antil iu finisim evri waka lo Australia. Sapos iu duim olsem, iu bae peim niu visa fo kam bak, en bae olketa no save givim iu.

Hao nao fo peim DASP?

DASP hem Olowe save pei insaet 28 deis from taem wea submitim nao komplit aplikason. Aplikason fo peiment wea hem no komplit o samfala sapot document lus bae hem delei. Mek sua aplikason blong iu hem komplit.

Super blong iu olketa save peim go insaet lo **Australian bank account**, , bae postim lo iu lo **Australian dollar cheque**, o peim lo international money transfer (fo fund aplikasons onli). Staka ovasis banks no save akseptim Australian cheques en no evri funds provaedem evri 3 peiment opsons. Checkem super fund blong iu abaotem gudfala peiment wei en

sapos eni fee en charges bae aplae. Sapos iu chus fo super pei go insaet Australian bank account blong iu, lu **MUST** livim Australian bank account blong iu open. Sapos iu no mekem DASP klaim blong iu insaet 6 manis lo visa expae deit, super blong iu bae save transfarem go lo ATO wea olketa bae holem antil iu klaimim. Super wea ATO holem hem onli pei go insaet lo Australian bank account.

Hao nao DASP taxed?

DASP blong iu bae olketa taxim bifo iu tekem, olowe tax reit hem 35 %-45%. Bae olketa givim iu peiment summary wea talem amaont blo DASP tax olketa holem en faenol amaont wea paim go lo iu.

Certified kopis blo pruf lo identity documents

Sapos value blo super blong iu hem \$5,000 o moa, super fund blong iu bae likem certified kopis long identity documents blong iu. Diswan hem save passport blong iu distaem wea garem picsa blong iu, passport namba, passport kaontri, en passport expae deit. O, save tu driver's licens blong iu distaem, o nasinol identity cad.

Garem spesifik rul abaoatem hu nao save certify documents. Hem isi fo certify documents taem iu lo Australia. Kontaktim super fund blong iu befo iu livim Australia fo stretem documents iu nidim. Lu save check tu wetem waka ples blong iu abaoatem hao fo certify documents.

Iu save also certify identity documents taem iu kam bak lo hom. Olketa pipol ea nao garem atoriti fo certify olketa identity documents aotsaed lo Australia:

- notary publics
- staff lo kolsap Australian
 - embassy
 - high commision
 - consulate – olsem consulates wea luk afta bae Austrade honorary consuls.
