Superannuation em wanem?

Superannuation, o super, em i retirement savings system bilong Australia. Em olsem ol Nasenel Provident Fund i save stap long planti kantri long Pasifik.

Sapos yu save wok long Australia, kampani yu wok long en bai i baim super bilong yu long 10.5% long pe bilong yu (long 1 July 2022). Super bilong yu ol bai i salim i go insait long wanem super fund yu makim, we bai i stap inap yu kisim taim yu go bek long ples bilong yu.

Pastaim long yu salim super claim, sekim kampani bilong yu olsem ol i baim pinis olgeta moni bilong yu i go long fund yu yet laikim. Kampani mas baim super bilong yu olgeta wanwan 3-mun [tasol sampela bai inap baim dispela moa klostu klostu].

Toksave: Dispela 10.5% Super Guarantee bai go antap 0.5% wanwan yia long de 1 Julai inap i kamap long 12%.

Wanem taim tru bai mi inap kisim super bilong mi?

Bai yu inap kisim super ol i baim yu sapos:

- yu lusim pinis Australia
- yu no wnpela citizen long Australia o New Zealand, o yu no residen long Australia.
- yu no holim yet wnpela visa bilong Australia, wantaim olgeta kain visa [wantaim tourist visa].

Help

Apply for departing Australia superannuation payment and/or payment of unclaimed superannuation money: how to apply

This system will analyse you to apply online for the departing Australia superannuation payment (DASP) from both super funds and the ATO. Please take some time to read through this section so you know what information you will need to provide to apply for your superannuation benefits using this system.

What will you be asked to provide

To help confirm your identity and process your application, you will need to provide the following information:

You will be asked to provide personal details such as your name, date of birth, tax file number (TFN) and password details. This information, (including your TFN), will be passed to the Department of Home Affairs to establish whether you have ever held a working holiday maker (WHM) visa. Confirmation of your eligibility may take a few seconds. If you are eligible you can then complete your application.

If you are applying for a DASP, you may only submit your application if you have departed Australia and your visa has ceased to be in effect (for example, it has expired or been cancelled). If you are still in Australia, or your visa is still active, you may save an application, but it cannot be submitted to your super fund(s).

Note: You must enter exactly the same personal details each time you access this system.

Secret password

To protect your information, when you first enter the system you will be asked to create a 'shared secret' by selecting a question and supplying your answer. This system will encrypt and securely store this information. If you are saving an application or exiting your application or when a new application, you will be asked to answer your question. You (or unauthorised persons) will not be able to proceed unless you supply the correct answer.

System searches for your superannuation

If you are applying for a DASP, you are eligible to apply for a DASP if you provide your TFN, the system will search the ATO's records to identify the super funds where your previous visa, themselves, may have been held. Even if you may have transferred income to the ATO, we recommend you contact your super fund(s) directly as well.

Add your contact and other personal details

You will need to provide your current contact details including your email and postal address. Your super fund and/or the ATO may need to contact you regarding your DASP application.

Your visa information

You will see the following: If you ever held a working holiday maker visa.

The Department of Home Affairs has advised that you have held a working holiday maker (WHM) visa.

Bai yu inap statim DASP akaun bilong yu pastaim long yu lusim Australia.

Statim DASP claim taim yu stap yet long Australia long DASP Online na wokim wanpela 'shared secret' bilong yu yet. Dispela bai mekim yu bai inap go insait long DASP Online long pinisim claim bilong yu taim yu go pinis long ples bilong yu, na visa bilong yu i pinis o ol i cancelim.

Pastaim yu bai lusim Australia, sekim pinis taim bilong visa bilong yu. Kampani yu wok long en bai inap soim yu long dispela. Sapos nogat yu yet go long Visa Entitlement Verification Online (VEVO) long internet long sekim dispela visa bilong yu.

Tingim: bai yu inap kisim super bilong yu bihain long taim yu lusim pinis long Australia na visa bilong yu i pinis taim. Yu bai no inap pinisim visa sapos i ananit long 6-pela mun stap yet long taim bilong en.

Na sapos mi gat visa bilong sampela yia?

Sapos yu stap long visa bilong sampela yia bai yu no inap kisim super bilong yu inap yu go pinis long ples bilong yu na ol i pinisim visa bilong yu. NO KEN pinisim visa bilong sampela yia inap yu pinisim tru wok bilong yu long Australia. Sapos yu mekim dispela, bai yu mas baim nupela visa gen long kam bek long Australia, na nogut ol bai no inap oraitim na givim yu.

Bai baim DASP olsem wanem?

DASP ol i save baim yu insait long 28 de long bihain long taim yu putim askim pepa. Sapos pepa bilong yu em i no stret tru olsem yu no raitim gut o sampela pepa wantaim long soim i stap nogut bai surikim taim. Yu mas sekim bai pepa bilong yu i stret tru.

Supa bilong yu bai ol inap putim insait long wanpela **Bank Akaun long Australia**, o salim long kam long yu long wanpela **Australian dollar cheque**, o salim wanpela international moni transfer long yu [long fund application tasol]. Planti bank long narapela kantri i no save kisim Australian cheque na planti ol fund i no inap larim yu yusim 3-pela we bilong ol baim yu. Sekim gut dispela super fund bilong yu olsem wanem gutpela we long ol bai i baim yu na bai yu baim haumas long dispela. Sapos

yu tokim ol long baim long bank akaun bilong yu long Australia, bai yu mas kipim dispela akaun long Australia i stap op tasol.

Sapos yu no askim long kisim DASP bilong yu insait long 6-pela mun bihain long visa bilong yu i pinis, orait nogut super bilong yu bai ol i salim i go long hand bilong ATO na ol bai holim i stap inap yu askim ol. Super moni we ATO i holim pas bai ol inap salim i go long wanpela bank akaun long Australia tasol.

Bai ol rausim takis long ASP olsem wanem?

- DASP bilong yu em bai ol i rausim takis long en pastaim long yu kisim, olsem rausim 35% inap long 45% long en. Bai ol i givim yu wanpela pepa long soim haumas tru DASP i rausim na haumas tru bai ol i salim long yu.

Dispela em olsem passport bilong yu we i gat foto, passport namba, kantri bilong yu, na pinis de long passport bilong yu. Na, nogut ol i askim long laisens bilong draivim car bilong yu o ID pepa long kantri bilong yu stret.

I gat strongpela lo long husat tru inap tokim ol pepa bilong yu em tru. Em i isi long wokim dispela taim yu stap yet long Australia. Toktok wantaim ol super lain bilong yu pastaim long yu lusim Australia long ol inap tok klia long wanem ol pepa ol i laikim. Tu yu inap askim kampani bilong yu long halpim yu long stremol dispela pepa.
