

Family accompaniment worker application form

This form is for long-term PALM scheme workers who wish to apply for the family accompaniment pilot. Please complete and sign the form and return it to your employer to submit as part of the application.

This form includes 2 parts: (1) a privacy notice and (2) the application form.

The Department of Foreign Affairs and Trade (DFAT) in collaboration with the Department of Employment and Workplace Relations (DEWR) is responsible for managing the Family Accompaniment pilot (the Pilot) for the PALM scheme.

The Pilot allows long-term PALM scheme workers to bring their immediate families to Australia and provides access to specific welfare payments while onshore. The Pilot aims to address the social impacts of extended periods of family separation. Participation is subject to employer agreement and a suitability assessment conducted by DFAT and DEWR.

Privacy notice

Part 1: Privacy notice

This notice explains how DFAT, DEWR, and their agents (referred to collectively as We/Our/Us) manage personal information collected about you in accordance with the *Privacy Act 1988* (Privacy Act).

If We do not collect the information in the Pilot application form, We may not be able to assess or approve your Pilot application or manage your participation in the Pilot.

Participation in research and media activities is voluntary and will not impact Our assessment of your application for the Pilot or your participation in the Pilot.

Why We collect personal information

We collect personal information about you and your family members to implement and manage the Pilot, including to:

- assess your application for Family Accompaniment
- manage participation in the Pilot
- evaluate and promote the Pilot, and
- investigate, manage and report on welfare issues and respond to incidents as part of Pilot.

What types of information We will collect from you and your family

To manage the Pilot, we may collect the following:

- full names
- dates of birth
- contact details including email, phone number and address (overseas and in Australia)
- employment information
- salary and any Australian government benefits

- passport details and visa information, and
- English language skills.

We may also collect sensitive information, including:

- language and cultural background information
- health information (e.g. medical history, test results, reports about incidents in Australia such as information about injury or illness), and
- any criminal history information (e.g. police checks).

How We collect information

We may will collect this information directly from you, your family, and from other people such as:

- your approved employer
- the government of your home country, or other countries you have lived in
- approved parties who administer tests
- Australian Government Agencies and Departments, such as the Department of Home Affairs, the Fair Work Ombudsman, the Australian Taxation Office, the Department of Health, Services Australia, and the Australian Federal Police (AFP)
- non-government agencies and private organisations, including those engaged by Us.
- any other person, agency or organisation which may be able to provide information relevant to your suitability to participate in the Pilot, and
- publicly available sources.

Who We will share your information with

We may share your personal information with:

- your approved employer
- Our agents and contractors (including to the operator of the Pacific Labour Facility)
- Federal, state and territory or local government departments, agencies or councils
- the government of your home country, or other countries you have lived in
- law enforcement agencies, including the AFP and State and Territory Law enforcement agencies
- Ministers and their officers, members of Australian parliament, and parliamentary committees
- diplomatic missions and consulates within Australia
- workplace health and safety and workers compensation agencies and/or health insurance providers that are delivering services to you
- universities, colleges, schools and other educational or training institutions for research and educational purposes (the information shared would be de-identified)
- global bodies and institutions for research purposes (de-identified data)
- any other person, agency or organisation which may be able to provide information relevant to your suitability to participate in the Pilot, and
- your or your family members' nominated next of kin if you are involved in a critical or serious incident.

Why We may share your information

We may share your personal information to other parties for the following purposes:

- to assist with Our assessment of your application to the Pilot
- to manage your involvement in the Pilot
- to assess, evaluate and improve the Pilot
- to conduct research regarding the Pilot, and
- to investigate, manage, and report on welfare issues and respond to incidents as part of Pilot.

Sharing information outside Australia

We may share personal information about you or your family with any parties listed above, including where they are located outside Australia, for the purpose of managing the Pilot.

Part 2: Application

It is important that you answer all questions on this form and check it carefully to make sure you have completed it correctly. If you do not provide all required information, you may not be selected to participate in the family accompaniment pilot.

To participate in the family accompaniment pilot, you and your family members will need to meet the family accompaniment eligibility criteria. The eligibility criteria are outlined below to help you, your family, and your employer determine if you are eligible for the pilot and wish to participate.

All applications will be assessed against the eligibility criteria and separate selection criteria. The selection criteria are available to view on the PALM scheme website. Meeting the eligibility criteria does not guarantee selection for the pilot as there are limited places available.

Please note: if selected to participate in the family accompaniment pilot, dependent family members will need to apply for and be granted a visa to travel to and remain in Australia.

Family accompaniment eligibility criteria

Workers

- Long a term PALM scheme worker/visa holder (1 - 4 years)
- Have the support of current employer to participate in family accompaniment.
- Have been employed with the PALM scheme in Australia for 10 months prior to applying.
- Have at least 18 months remaining on visa/work contract at time of application.
- A national of a country that is participating in the pilot (Timor Leste or Kiribati).

Families

- Eligible family members are those that are members of the family unit within the meaning of the Migration Act 1958. That is, the spouse/de facto partner of the PALM worker and eligible dependent children.
- To be eligible, your child or your partner's child must be:
- your child, and/or your partner's child, who is not engaged, married or in a de facto relationship and is:
 - aged under 18 years, or
 - aged 18 to 23 years and dependent* on you or your, partner for basic needs of food, clothing and shelter, or
 - aged 23 years or older and wholly or substantially reliant on you or your partner because they are incapacitated for work due to the total or partial loss of bodily or mental functions, or
 - the dependent child of the child above.

- All family members will need to meet the conditions of a Temporary Work (International Relations) (subclass 403) PALM stream secondary applicant visa.
- Partner/spouse must agree to participate in a pre-departure briefing prior to arriving in Australia.
- Partner/spouse must have at least a basic/beginner level of English.
