## Wat nao consent?

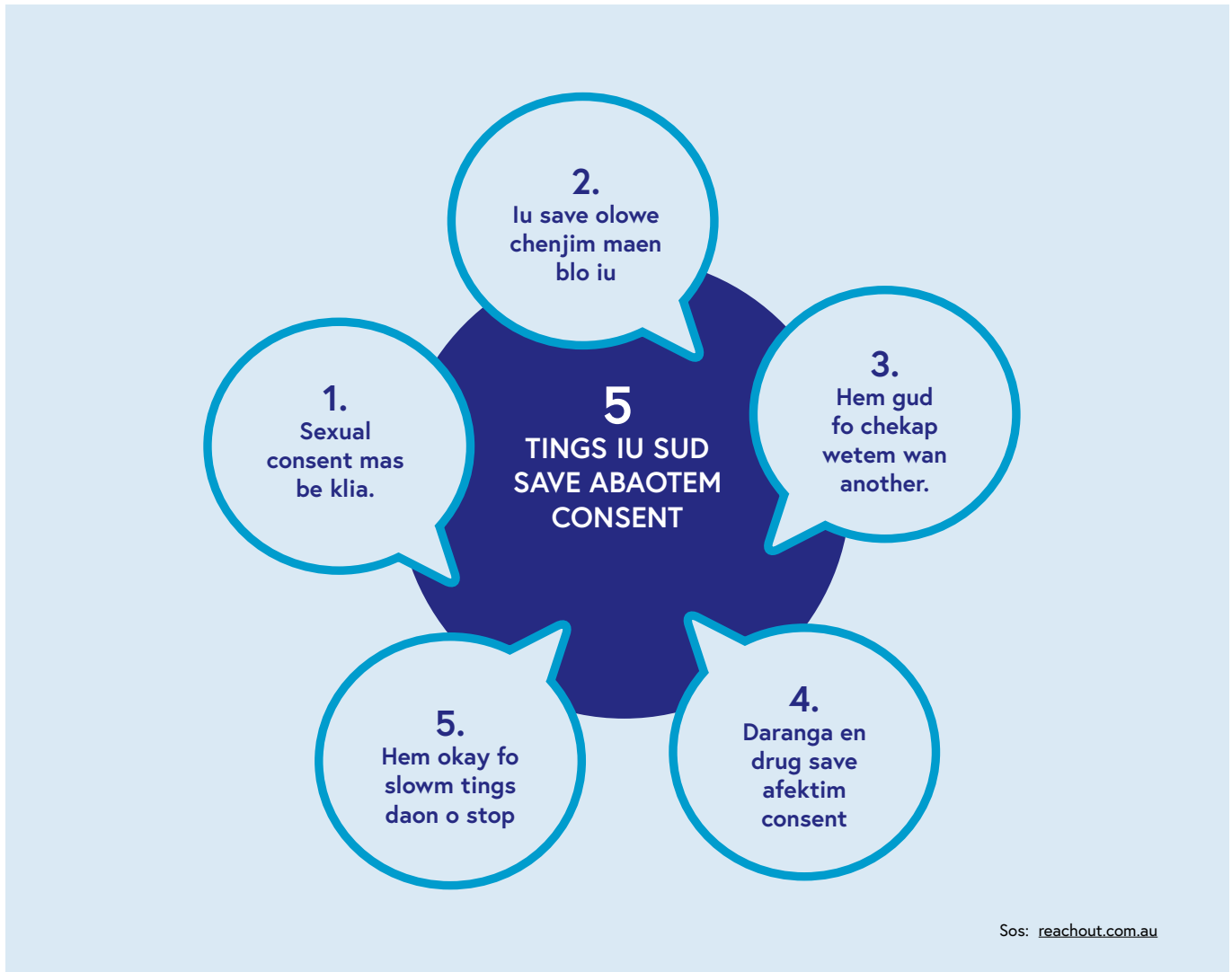

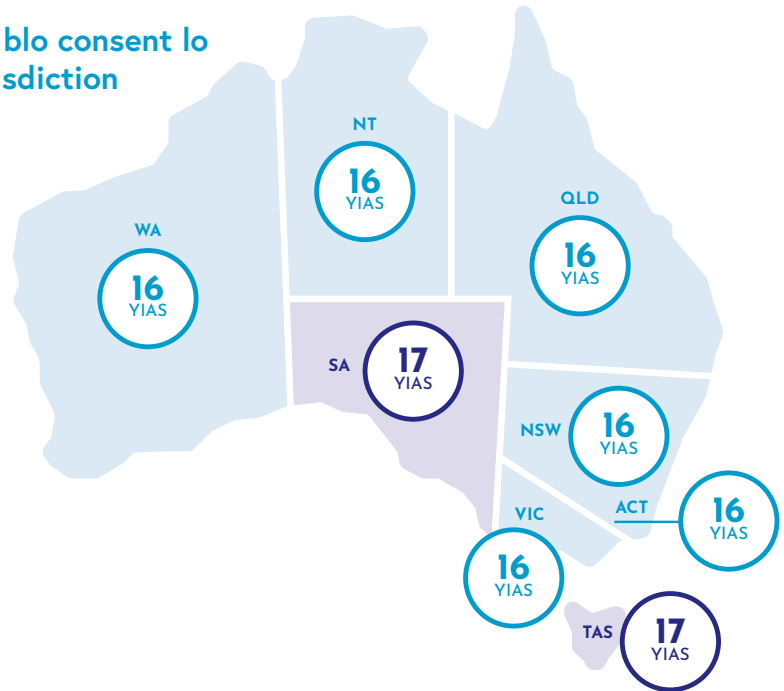

## Wat hapen sapos samwan brekem olketa laws?

Sapos samwan olketa faedem gilti fo brekem laws abaotem sex en consent, olketa save konvikted lokriminol ofens. Kriminol ofens hemi save resalt lo penoltis olsem faen o taem lo prison en hem save afektim stap blong iu insaet lo Australia. Samwan wea hem bin konviktd lo sexual ofens agenstim pikinini bae save putum lo Child Protection Offender Register.

Sexual assault hem wanfala kriminol act wea save repotem lo polis en olketa bae panisim anda lo kriminol codes, eniwea hem happen – lo sosol taem, lo haus, o lo waka.
