 Ha, Astrelian kanūn ke niche, agar āp apan bōs ke khatin lagatār bāra mahina kām kara he to apan baccha ke hoe la janam ke tarik se pahile, to āp (ya āp ke pātna) ke bāra mahina ke bina talab ke perantāl chutti le ke adhikār he agar āp (ya āp ke pātna) ke baccha ke dekh bhāl kare ke jimwāri he. Āp ke apan bōs ke das hpta pahile mango batae do agar chutti le mangta he.

Enṭi-diskriminaishan kanūn ke niche agar āp bāra mahina tak kām nai kara he, tab bhi āp bina talab ke chutti ke bare me apan bōs se bāt kare sakta he. Āp ke bōs āp ke chutti ke arzi ke manā nai sake kare āp ke sekz, garab awastha ya parwār ke jimwāri ke karan.

Is se ulong ke mauka mile he baccha ke khatin sahi vyabhstha kare ke agar ulong Astrelia lauṭ ke apan laiba mobiliṭi kām ke mange jāri rakhe.

Agar āp mangta he ghare lauṭ ke apan baccha ke janam de, to āp ke chahi he apan dokṭa se bāt kar ke pata lagao ki āp garab ke kon halat me he jis se āp sakta he apan laute ke vyabhstha kare sake jab āp međikāli thik he. ## Astrelia me janam de ke khatin hamme paisa bhare ke padī?

 Ha, Astrelia me PALM skim ke niche kām kare la taem garab karamchāri aur uske pātña pura swast ke kharcha ke jimawār rahi. Međikal insurans jon āp ke visa ke ek shart he kuch rakam se āpke paisa ke bharai me maddat kare he, lekin Astrelia me kafi međikal insurans garab se juda kharcha aur janam de la kharcha (obsteriktiks) ke nai kava kare he, jab tak ki āp insurans ke bāra mahina se jada sameae tak nai rakha he.

Agar āp insurans ke bāra mahina ke sameae ke pura nai kara he lekin fir bhi Astrelia me rahe ke mangta he janam dewe, tab i bahut jaruri he ki āp kharcha ke bare me soch lo kahes ki u bahut mahanga he. Ap
